TOWN POLICE CLAUSES ACT 1847, SECTION 21
THE DISTRICT OF NEW FOREST (PREVENTION OF OBSTRUCTION,
ETC., VARIOUS ROADS COPYTHORNE) ORDER 2018

The NEW FOREST DISTRICT COUNCIL by virtue of its powers under Section 21 of the Town Police Clauses Act 1847, and of all other powers them enabling in that behalf and after consultation with the Hampshire County Council and the Chief Officer of Police for Hampshire hereby make the following Order: -

WHEREAS the streets specified in Article 1 of this Order will be thronged or liable to be obstructed on the days and during the hours specified in the said Article, the Council do HEREBY ORDER AND DIRECT that for the purpose of preventing obstruction in the said streets on the said days the following regulations shall be observed.

1. On Saturday 9th June and Sunday 10th June 2018 the streets set out below shall be closed for vehicular traffic:-

Layby outside Copythorne School	“	1000 hrs to 23.59

2. Nothing in this Order shall prevent the use of the said streets or length of streets by vehicles of the Fire, Police or Ambulance service or of the Local Authority in the performance of statutory functions or of the statutory undertakers if there is no other street which would equally serve those purposes.
