From Forest boundary, through double wooden gates, eastwards along grass track approx. 10 ft. wide between wire fence and copse, along gravel road approx. 10 ft. wide and then along road enclosed between wire fence and hedge to Parish Boundary, north of Goldenhaves. |
| Copythorne 2 | Footpath | 2947 1365 Road U137 near White Hart Inn | 2937 1359 A31 Southampton Road | From Road U.137 north of Cadnam roundabout to Road A.31. From Road U.137 near White Hart Inn southwestwards along grass path enclosed approx. 4 ft. wide then unenclosed across grass to Road A.31. |
| Copythorne 3 | Footpath | 3110 1462 Pound Lane | 3172 1472 Burrow Hill Road | From Road U.138 east of Copythorne, to junction with Road U.138 at Money Hills Farm. From U.138, over wire fence, eastwards along verge of pasture on north side of hedge, over wire fence, along verge of pasture, over single strand wire fence, along 4 ft. wide headland of arable field, over hedge, along verge of pasture and over padlocked double wooden gates to junction with U.138. |
| Copythorne 4 | Footpath | 2985 1504 Newbridge Road | 3081 1487 Romsey Road (A31) | From Road C.107, south of Newbridge, to junction with Road A.31 at Copythorne. From C.107, over stile, and northeastwards along 5 ft. wide earth path enclosed by hedges, through kissing gate, along path enclosed by wire fence and hedge, over stile, the eastwards along unenclosed path on north side of hedge, southeastwards along 3 ft. wide grass track across gorse, over stile (at field gate), crossing gravel drive of "Paultons", along 6 ft. wide grass track across gorse, along track skirting northeast of Copythorne Hill, and then eastwards along 10 ft. wide gravel road to junction with A.31. |
| Copythorne 5 | Footpath | 3073 1476 Road A31 | 3050 1430 Road C107 | From Road A.31, at Copythorne, to junction with Road C.107, southwest of Vicarage. From A.31, through kissing gate, southeastwards along verge of grass field, then southwards along 10 ft. wide earth path enclosed between wire and wooden fences skirting east of cemetery, over stile, then along unenclosed track across gorse, then southwestwards along track on southeast side of hedge, over stile, along gravel road approx. 8 ft. wide enclosed by hedges northwest of Scammel's Farm, over stile at swing gate, and then along road to junction with C.107. |
| Copythorne 6 | Footpath | 3079 1470 Footpath 5 | 3107 1476 Pound Lane north of Brooksbank | From No. 5, north of Copythorne Church, to junction with Road U.138, south of Copythorne House. From No. 5 northeastwards along verge of grass field, over stile, eastwards along 4 ft. wide grass path across gorse, then along path, skirting northern boundary of "Brooksbank", and over stile at field gate, to junction with U.138. |
| Copythorne 7 | Footpath | 3119 1283 Chinham Road | 3143 1273 Parish Boundary | From Road C.141, at Duncan Cottage, to Parish Boundary. From C.141, over stile at field gate, along undefined path shown on Eling Inclosure Award dated 1816 as a public footway 6 ft. wide, across pasture, and over stile to Parish Boundary. |
| Copythorne 8 | Footpath | 3000 1340 Road A336 | 2996 1327 Bridleway 18 | From Road A.336, west of Coach and Horses Inn, to No. 18. From A.336, over stile at field gate, southwards along verge of pasture on west side of hedge, and over stile to junction with track at Forest boundary. |
| Copythorne 9 | Footpath | 2948 1430 Cadnam Green | 2984 1396 Romsey Road (A31) | From Cadnam Green, to junction with Road A.31 north of Cadnam. From unenclosed grass of Cadnam Green, over stile, along 5 ft. grass headland of arable field on north side of hedge, over stile, along undefined track across pasture north of stream, over 2½ ft. brick footbridge and southwards along 4 ft. wide grass headland of arable field on east of stream, through gap, southeastwards along grass track across pasture on south side of wire fence, through kissing gate, then along undefined track across narrow pasture enclosed between hedge and wire fence, and through kissing gate to junction with A.31. |

| Copythorne 13 | Footpath | 2975 1385 Road A31 | 2983 1379 Old Lyndhurst Road | From Road A.31, northwest of Cadnam, to junction with Road U.137 From A.31, over culvert, over stile, and southeastwards along unenclosed earth path 3 ft. wide across grass field on south side of hedge, along 12 ft. wide gravel road between hedge and workshop buildings, and then over culvert to junction with U.137. | |
| Copythorne 14 | Footpath | 3187 1526 Junction Footpaths 15 and 16 on Barrow Hill Road | 3214 1540 Whitemoor Lane | From Road U.138, east of Copythorne Common, to junction with Road C.129 From U.138 northwards along gravel track approx. 9 ft. wide across gorse to junction with C.129 | |
| Copythorne 15 | Footpath | 3187 1526 Junction Footpaths 14 and 16 on Barrow Hill Road | 3207 1561 Whitemoor Lane | From No. 14 north of Money Hills to junction with Road. 129 From No. 14 at junction with U.138 northwards along gravel track approx. 9 ft. wide across gorse to junction with C.129. | |
