INTRODUCTION

- i. This document is designed to assist Copythorne Parish Council and those living within the Parish to be able to understand their own risk of flooding and to be better able to prepare and respond to a flooding event affecting their property or in their immediate area.
- ii. You can check the flood risk in the general area of your home by consulting the details shown on page 2 opposite.
- iii. **If you are seeking help urgently please go immediately to the back page of this leaflet where emergency contact details are given.**
- iv. Whilst any area or property can be at risk of flooding, the Environment Agency surface water flooding maps of the area, combined with the knowledge of past flooding incidents, have shown the areas of the Parish that are vulnerable to surface water flooding and more details are to be given in later update reports from the Council Flooding Advisory Committee.
- v. Property owners are responsible for the protection of their own properties and some house owners within the Parish have already installed flood protection measures to make their homes more resilient to a flooding incident.
- vi. Property owners are responsible for protecting their own properties and it should be noted that the New Forest District Council (NFDC) no longer provides sand bags to homeowners.

CHECKING THE LONG TERM FLOOD RISK IN YOUR AREA

Use the following link to find out:

The long term flood risk for an area in England; the possible causes of flooding; and how to manage flood risk

The results are an indicator of an area's flood risk, particularly the likelihood of surface water flooding.

It is not suitable for identifying whether an individual property will flood.

It does not include the flood risk from sources such as blocked drains.

The Government/Environment Agency <https://flood-warning-information.service.gov.uk/warnings> is continually being updated with flood warnings and gives further links to more information. The nationally recognised warning system has three levels that are designed to help individuals and communities prepare for the risk of flooding and take action.



FLOOD ALERT

What it means:
FLOODING IS POSSIBLE

BE PREPARED



When it's used: Two hours to two days in advance of possible flooding
Impacts likely to be seen: Flooding/standing water on fields and roads, watercourses near to or exceeding their capacities and overflowing footpaths and roads.

What to do: Monitor water levels in watercourses near to your home and/or business. Regularly check current flood warnings and local news reports



FLOOD WARNING

What it means:
FLOODING IS EXPECTED

IMMEDIATE ACTION REQUIRED



When it's used: Half an hour or one day in advance of possible flooding
Impacts likely to be seen: Flooding of homes and businesses. Flooding of roads making some impassable. Major transport disruptions. Extensive flooding of open forest areas -overtopping of rivers into adjoining areas.

What to do: Protect yourself, your family and, if possible, help others. Move family, pets and valuables to a safe place. Put flood protection equipment in place, check pumps etc. If you are caught in a flash flood, get to higher ground.



SEVERE FLOOD WARNING

What it means:
SEVERE FLOODING

DANGER TO LIFE



When it's used: When flooding poses a significant threat to life or disruption to communities
Impacts likely to be seen: Fast and, especially in watercourses, deep flowing water. Severe road flooding. Forest areas inundated. Some roads/footpaths impassable to pedestrians and vehicles. Flood water contaminated with sewage.

What to do: Stay in a safe place, make contact with family and neighbours. Be ready should you need to evacuate from your home. Cooperate with the emergency services.

TYPES OF FLOODING

1. There are many recognized types of flooding sources, including:
 - Sea (tidal)
 - River (fluvial)
 - Surface Water (roads, ditches, fields)
 - Groundwater (high water table)
 - Sewage (sewer, rising mains and wastewater pumping stations)
 - Potable Water (mains drinking water failure)
2. The main causes of surface water flooding in the Parish of Copythorne arise from Bartley Water and Cadnam River overflowing or from surface water that is unable to run away or disperse through natural drainage or drainage systems that have been constructed.
3. Inevitably when flood water is at a level that is flowing across roads, fields and forest areas there will be substantial infiltration of surface water into the piped foul sewage system leading to the possible contamination of flood water entering gardens and properties.

TYPES OF WATERCOURSES

A Main River is defined as a watercourse identified as such by legislation and can include any structure or appliance for controlling or regulating the flow of water in, into or out of a main river. The Environment Agency has powers to carry out flood defence works on main rivers only.

Within the Parish of Copythorne are the Main Rivers of Cadnam, Blackwater and Bartley Water. In addition, because of their importance in relation to reducing the risks of flooding, several watercourses have been designated main rivers.

The location within the Parish of Copythorne and adjoining areas of Main Rivers are shown on the plan available for viewing on the dedicated section of the Parish Council's website.

All other watercourses are designated as being ordinary watercourses - whether on public or privately owned land - and come under the regulation of the Lead Local Flood Authority (LLFA) which is Hampshire County Council

A WATERCOURSE NEAR TO OR ON YOUR PROPERTY - RIPARIAN RESPONSIBILITIES

1. It is very likely, if you have a watercourse close to your boundary or on your property, you have riparian responsibilities. Your responsibilities for watercourses on or near your property and permissions you need to do work around them are given on the following link: <https://www.gov.uk/guidance/owning-a-watercourse>
2. There are very few circumstances where a ditch or watercourse located between your property and a public footpath or road is not, under your riparian responsibility, for you to maintain in good order. Any pipe/culvert under a vehicular crossover from the road to your property is your responsibility to keep free flowing.
