COPYTHORNE PARISH COUNCIL MEETING – TUESDAY NOVEMBER 9TH 2021

Item 14 - Correspondence & Clerks Report

1. Affordable Housing in the Parish

I received an e-mail from English Rural Housing Association ("ERHA") on Wednesday October 27th 2021 to advise that they are now in a position to go live on the consultation website reported at last month's Council meeting.

The email advised that it was proposed that the website would go live on November 1st 2021. The link is: https://copythorne.englishrural.org.uk

The proposals are for a development of 10 affordable homes for rent as follows:-

4 x 2-bedroom / 3-person flats

4 x 2-bedroom / 4-person houses

2 x 3-bedroom / 5-person houses

ERHA also sent me a draft copy of a letter being sent to residents local to the proposed site to ensure that they are specifically aware of the current proposals. A copy of what has been sent is attached. The letters were expected to arrive November 1st.

An article was added to the home page of the Council's website on November 1st 2021 with a post added to our Facebook page on November 2nd 2021. Details will also be included in an article for the December edition of our newsletter which will be released around two weeks before the consultation period ends on December 13th 2021.

A copy of the letter to residents referred to above will be placed on each of our noticeboards once I know that the individual letters referred to above have been received.

- **2. New Inn Road, Bartley** When HCC Highways inspected the road surface in August 2021 they advised that *"the road has been inspected again, no maintenance is programmed."* Another quarterly inspection will be due in November and I will seek an update in early December.
